Exploring Gaps in the Response: The Syringe Access Fund

Location: Academy Hall

The final plenary on Day 1 will explore the philanthropic response to the highly politicized issue of syringe access. The U.S. CDC calculates that over 5,000 Americans who inject drugs are newly diagnosed each year with HIV. While evidence has shown that syringe exchange programs (SEPs) significantly reduce transmission of HIV, hepatitis C, and other blood-borne illnesses, without promoting drug use, and help connect people who inject drugs to other health services, they have been limited by a longstanding federal funding ban.

One critical resource responding to this issue, the Syringe Access Fund (SAF), was launched in 2004 – with founding partners Levi Strauss Foundation, Elton John AIDS Foundation, the Irene Diamond Fund, the Tides Foundation and AIDS United - as a unique funding collaborative to fill a critical gap in supporting syringe exchange and related public policy activities. With heroin and other injection drug use increasing across all demographics in the US, the need for needle exchange is expanding while resources of the fund are diminishing due to the recent sun-setting of one of its key founding partners, the Irene Diamond Fund.

Session 1: Protections of and Barriers to Access to Care 10:30 AM – 12:00 PM

We will begin to dive into health equity in the US by examining issues of access. What gains have we achieved through the Affordable Care Act? Where are the gaps and who is left behind? What should our strategies be for achieving equitable access, especially for populations with the greatest needs and the most barriers? Panelists will discuss such topics as Medicaid expansion, Pre-exposure prophylaxis (or PrEP), women's health, mental health and addiction, and gender identity access issues.

Session 2: Health Equity for Women of Color 1:30 PM – 3:00 PM

Reproductive rights, and women's health in general, have long been a political football. And while 30% of women in the US are women of color, systematic obstacles further impact their access to healthcare. Not only do women of color experience higher maternal mortality and HIV and STD rates, they also often lack access to basic reproductive health care – or new innovations such as PrEP. In this session, we will focus on the needs of women of color, and drill down into issues faced by subpopulations.

Session 1: Start Free, Stay Free, AIDS Free

As a result of effective organizing and activism, the UN’s recent High Level Meeting on HIV/AIDS generated a statement that called for increased attention to the needs of children and adolescents, including increased access to treatment, and more treatment options. The Start Free, Stay Free, AIDS Free initiative, rolled out at the International AIDS Conference in Durban, seeks to further fast track efforts by dramatically reducing the number of children newly infected with HIV to less than 20,000 by 2020 and aggressively increasing the number of children on treatment to 1.6 million by 2018. In this session, we will explore the new architecture for structuring the response to children’s needs and issues.

This bridge session will connect our other international conversations on children and youth and key populations by exploring the special needs and circumstances of the children of key affected populations. These children face the double burden: both the effects of HIV and AIDS and entrenched stigma by way of association with their parents. As a result, they are excluded from local services and overlooked both by interventions for key populations and by broader social and economic development. This session will report out on a recent two-year project by the Coalition on Children Affected by AIDS to define these issues and create an advocacy agenda for this overlooked group.

In the final session of the day, we will explore that fund and other resources available to address the needs of key affected populations. We will also examine how community-led organizations are navigating this terrain and working to ensure sustainability of their efforts.
