FCAA DATA SPOTLIGHT HIV PHILANTHROPY FOR SEX WORKERS (2017)




This infographic provides an analysis of philanthropy disbursed for HIV-related efforts in 2017 that addressed the needs and rights of sex workers.

Sex workers are 13 times more at risk of HIV compared with the general population, due to an increased likelihood of being economically vulnerable, unable to negotiate consistent condom use, and experiencing violence, criminalization and marginalization.

Yet, this population received only \$13.9 million in 2017 – roughly 2% of total HIV philanthropy in 2017, and a 24% decrease from 2016.

Data for this infographic is distilled from the Funders Concerned About AIDS (FCAA) annual report *Philanthropic Support to Address HIV/AIDS in 2017.* Data analyzed for this includes both grants that specifically address the needs of sex workers, as well as grants that target key populations in areas where sex workers are disproportionately impacted.

In 2017, \$13,908,008 of HIV-related philanthropy supported sex workers.




Almost **\$900k** went to organizations **doing work on a global level**, often to advocacy/human rights-based programming done by global networks of sex workers.

IMPORTANT HIGHLIGHTS

- A strong trend in advocacy and empowerment programs for sex workers: 62% of funding focused on advocacy and human rights-based programming, while 31% (\$4.3 mil) went to capacity building and leadership development among sex workers.
- Funders are supporting access to PrEP (pre-exposure prophylaxis): Just under \$1 mil (or 7%) of this funding supported PrEP-related efforts.
