

1. Where is the Forum taking place?

The Forum will take place in-person at the True Reformer Building, home to the Public Welfare Foundation and virtually via Zoom. The True Reformer Building is located at 1200 U Street, NW, on the southwest corner of 12th and U Streets. 2. How can we participate virtually?

FCAA is providing free virtual attendance via zoom. In the registration system, Participants attending virtually should select "virtual attendance." FCAA will follow up with further instructions on how to access the zoom. During the event, this option will allow attendees to watch the Forum live, and share questions in the Zoom chat/Q&A function. Event moderators will work to include questions/comments submitted virtually as they are able.

3. What is the event's COVID policy?

The True Reformer Building requires a proof of COVID vaccinations to enter the building. Digital or hard copy proof will be accepted. Additionally, masks are required when in all public spaces (i.e. outside of the Langford auditorium).

FCAA's goal was to make this as inclusive as possible for all attendees. This included partnering with a venue with strong COVID policies, offering virtual attendance options, and monitoring our attendance limits to ensure appropriate spacing within the meeting room. We will also encourage masks when not eating in the meeting room and will provide masks for those who need them. The FCAA Advocacy Forum is free to attend for FCAA Members and virtual participants. There is a \$50 fee for representatives of non-FCAA member organizations. Invited speakers will also receive free registration via a special discount code.

5. What does registration include?

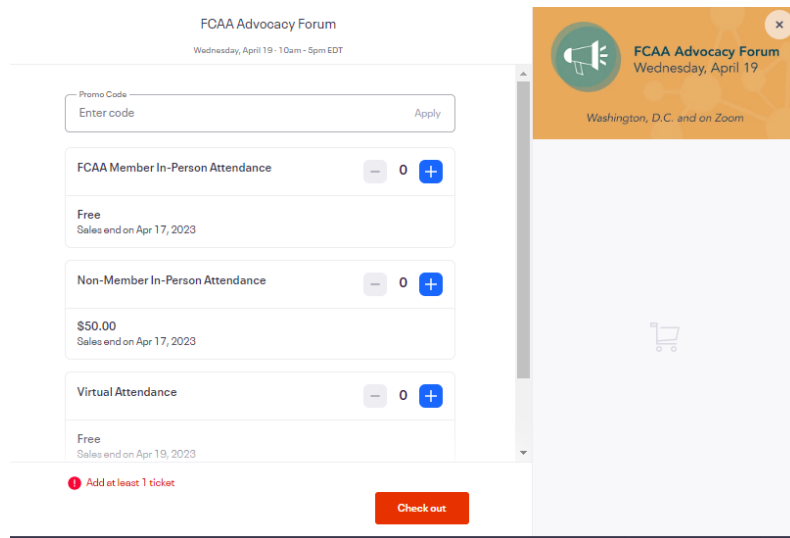
Registration provides access to the full-day meeting, lunch, and a dessert networking hour.

6. How do I register?

FCAA is running registration online via Eventbrite. To begin registration, click on the "Reserve a Spot" red button, as demonstrated below.



Next, you can select a ticket type for attendance.



In the final steps, you will provide your contact and organizational details, and any accessibility or dietary needs (if attending in person). If you are attending in-person as a non-FCAA member organization, you will be provided a credit card payment option to submit your registration fee.
